Please note the following:

- Students' existing classes/teachers will not change.
- The rotating schedule will be viewable via the Community Portal this weekend.
- Teachers will be reviewing updated procedures and details with students this Friday, April 30th.
- Per state guidelines, students must attend in-person (5 days per week) or fully remote (5 days per week). Hybrid is no longer an option.
- Students who are scheduled for in-person instruction must attend in-person in order to be marked present and participate in extracurricular activities.
- Students should bring their lunch with them and will not have access to refrigerators nor microwaves. The only approved outside lunch vendor is *The Little Sandwich Shop*, and ordering details can be found [here](#).
- Water bottles are encouraged as fountains may only be used to fill water bottles.
- In-person learners arriving after 9 AM will not be eligible for after-school activities that day.
